Further I on behalf of _____ (minor child) and myself agree to indemnify and hold Honda harmless from and against any and all claims, liabilities, damages, and expenses, including costs and attorney's fees, arising from any injury or damage that may result to _____ (minor child) occurring or arising in connection with participation in any activities.
